Purpose and Effect of the Zoning By-Law Amendment

The property is currently zoned "**Rural-71A (H), Rural-71B (H), and Rural-71C (H) and Environmental Protection (EP)**" in the Municipality's Comprehensive Zoning By-law No. B2014-070, as amended. The purpose of the application is to amend the RU-71B (H) Zone to include a parking lot and a future assembly/storage structure approximately 142.8 sq. m (1,536 sq. ft.) The property had undergone a previous zoning by-law amendment in 2017 to recognize the existing structures and permitted uses on the subject lands as approved by By-Law B2018-055. It is also being proposed to remove the Holding Provision from the Rural-71A, 71B and 71C Zones.

The applicant has submitted a proposed site plan which is available for public review at the municipal office during regular business hours and on the website under the "Current Planning Applications" tab.

Representation and Notification

Any person may attend the in-person or electronic public meeting and make written and/or oral submissions either in support of or in opposition to the proposed amendment. In order to participate electronically, please register for the webinar. It is the responsibility of the interested member of the public to have technology in place to connect to the meeting.

If a specified person or public body does not make written or oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the specified person or public body is not entitled to appeal the decision to the Ontario Land Tribunal (OLT).

If a specified person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the specified person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal (OLT) unless, in the opinion of the Board, there are reasonable grounds to do so.

If you wish to be notified of the decision of the Council of the Municipality of Trent Lakes on the proposed Zoning By-law Amendment, you must make a written request to the Municipality of Trent Lakes, at 760 County Road 36, Trent Lakes, Ontario, K0M 1A0.
