### **Purpose and Effect of the Zoning By-Law Amendment**

The subject lands are currently zoned “Rural Residential (RR) & Environmental Protection (EP)” in the Municipality’s Comprehensive Zoning By-law No. B2014-070, as amended. The purpose of the proposed Zoning By-law Amendment is to rezone the property from “Rural Residential (RR) & Environmental Protection (EP)” Zone to a “Rural Residential (RR) with a special exception”.

The applicant has provided a Wetland Delineation Study by Cambium to support the removal of the Environmental Protection Zoning from the property. The study also supports a site specific amendment to the subject property regarding section 4.30.7 of the Municipality’s Comprehensive Zoning By-law which requires a 30-metre setback from an Environmental Protection Zone boundary.

The applicant has submitted the following information, which is available for public review at the municipal office during regular business hours and on the website under the “Current Planning Applications” tab:

1. Wetland Delineation Study by Cambium dated July 22, 2024

### **Representation and Notification**

Any person may attend the in-person or electronic public meeting and make written and/or oral submissions either in support of or in opposition to the proposed amendment. It is the responsibility of the interested member of the public to have technology in place to connect to the meeting.

If a specified person or public body does not make written or oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the specified person or public body is not entitled to appeal the decision to the Ontario Land Tribunal (OLT).

If a specified person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the specified person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal (OLT) unless, in the opinion of the Board, there are reasonable grounds to do so.

If you wish to be notified of the decision of the Council of the Municipality of Trent Lakes on the proposed Zoning By-law Amendment, you must make a written request to the Municipality of Trent Lakes, at 760 County Road 36, Trent Lakes, Ontario, K0M 1A0.
