The Municipality of Trent Lakes offers a pre-authorized payment plan comprised of automatic withdrawals from your bank account to pay property tax arrears. Participation in this program will enable you to bring your taxes up to date but will not eliminate penalty charges. Once your account is up to date, we will switch you to the regular pre-authorized payment plan which does not incur penalty.

To take advantage of the program, please complete this application form and return it with a void cheque or bank letter to the contact information above.

**All changes to your pre-authorized payment plan (e.g. bank account changes, cancellations, property ownership changes) must be received at least TEN (10) DAYS prior to the next scheduled payment.**

### Property Tax Arrears Monthly Plan (12 Months)

The monthly arrears plan runs for twelve (12) months of the year with a fixed payment amount.
